- b) Participant is responsible for her escort who must wear a Barong Tagalog.
- c) Participant will be responsible for their own costume and transportation and any associated costs.
- d) Participant must be in appropriate Filipiniana attire.
- e) Prizes will be awarded to the FilCom Fiesta Jubilee Queen and 4 Princesses. Prize recipients shall be solely liable for any governmental taxes associated therewith.

- f) Participant must attend the mandatory briefing meeting which will be held on Saturday, April 15, 2017 at 1:00 p.m. at FilCom.
